As another exciting year of STAGE Camp is ready to kick off, our production team wanted to make you aware of some information that is specific to this year's camp.

- This year's show, *LEGALLY BLONDE, JR.*, contains a song entitled "Omigod You Guys". While this song is an iconic number from the original production, we also understand that the song's title and lyrics may be deemed inappropriate by some parents. Unfortunately, due to the contractual obligations of our licensing contract, we are not at liberty to change the line. However, if you do not feel comfortable with your child singing or participating in this particular number in the show, we are more than willing to excuse your camper from being a part of this song. The option to "Opt Out" of this number will be provided at auditions. However, opting out of the number may impact casting, as there are four roles required to perform in the number, based on script specifications.
- Please be advised that a fundraiser will be conducted during this year's camp. **PARTICIPATION IN THE FUNDRAISER IS NOT MANDATORY!** We always strive to keep our camp affordable, however, there are many costs associated with the production, so fundraisers are used to help offset the costs which are not covered by tuition and ticket sales. More details will be provided at auditions.
- Costuming for this year's production will consist predominately of standard street clothes. As a result, your child may be asked to provide certain costume pieces from home. Costume needs will be determined once roles are assigned after auditions, but please be prepared for the possibility of being asked to provide something other than the standard black pants and black shoes, as has been requested in past years. However, we do not want these changes to pose any financial issues to any families, so we will be happy to work with all families to make sure that each camper is taken care of.
